# **ISTS Congress/World Congress on Twin Pregnancy**

### FLORENCE, ITALY APRIL 2012

This year, the ISTS Congress was combined with the World Congress on Twin Pregnancy, so there were four days of presentations, hearing lots about multiples – from pregnancy and birth through to adult life.

Here are some snippets from the presentations made during the ICOMBO sessions:



**Opening Reception** 

Donald and Louis Keith, of CSMB requested mothers of twins to complete an online survey on Post-Partum Hemorrhage (PPH) late last year. The results of this survey showed a very significant risk of PPH for mothers delivering a multiple birth. More research will now take place to quantify the risk and hopefully prevent deaths in the future.

Twinship is a great resource when twins are commencing school. Studies have shown that the effect of school placement is very important in the development of the twins. It is known that when starting school, problems are less likely if the twins are placed together. However little research has been done

to seen what placement is most effective as they get older. The common belief is that each set of twins should be treated individually rather than have a rigid set of rules for all twins (unfortunately this does happen in some countries).

- A study in USA found that most teachers had no idea that there has been any research done on multiples in school; and nearly 50% of teachers interviewed had no knowledge of the school's policy on placement of twins in the classes. This study also found that the best placement policy is a flexible one – and that teachers need to be made aware of this.
- Alessandra Piontelli gave a thought-provoking presentation about the life of multiples in some of the less westernized countries. She has written a book- *Twins of the World: The Legends They Inspire and the Lives They Lead*.

The representative from Multiple Births Canada talked of the work they have done with a reproductive technology organisation in Canada to produce leaflets about life with multiples. These leaflets would be intended for people who may be expecting multiples, or are making decisions about fertility treatments, so they can be a little prepared for what to expect if they have a multiple birth.

NOMOTC (USA) presented an overview of how their Research Department is structured, their process for identifying research topics, and how they work jointly with outside researchers.

ICOMBO members also attended many sessions presented by researchers and doctors attending the joint Congress.

#### WHAT IS SAMBA?

SAMBA is a support group for parents with multiple-birth children. It is a non-profit organization, founded in 1975, and headed by a National Committee. Activities are controlled on a local group basis, in various areas throughout Southern Africa. All administration is controlled from Gauteng by the National Committee.

#### WHO CAN BELONG TO SAMBA?

Parents or caretakers of twins or higher order multiples, parents-to-be of multiples, adult twins and super twins may join the association. This includes foster parents, guardians and single parents. SAMBA draws its members from the RSA and our Southern African neighbouring states and countries.

### WHAT DOES SAMBA OFFER?

The primary purpose of SAMBA is to offer emotional and moral support to parents and to increase understanding and awareness of child development and rearing, which relates especially to multiple birth families.

SAMBA allows its members access to reading and research material, especially concerning the rearing of multiple birth children. The "Multiple Magic" which is a bi-monthly publication is compiled by the National Committee sourcing its information locally and abroad and also serves as the mouthpiece of the organization. In this respect SAMBA also seeks to acquire and contribute to the latest research data to maximize the benefits to its members.

SAMBA forms a network of contacts between parents of multiples, their doctors, educators, and others having an interest in caring for families and children. It focuses attention on solutions to problems specifically related to multiple-birth children and their families.

SAMBA creates awareness amongst the public of what it means to be a parent or sibling of multiples. It promotes the individuality of the child.

SAMBA recognizes that the material needs of a member family is often put under strain and therefore runs a second-hand facility we like to call "Samaritan" and negotiates discounts on products such as milk formula and baby equipment.

#### WHERE IS SAMBA?

SAMBA is within easy access of city dwellers at local groups, and country groups are run for those in the outlying areas. Regular get-togethers are arranged by key members of SAMBA in each area, often addressed by guest speakers, to provide an informative atmosphere of awareness, togetherness and friendship. # **Meet your ICOMBO Board Members**

## **Donald Keith**



Mr. Keith is the co-founder of The Center For Study of Multiple Birth, located in Chicago. The Center's purpose is to stimulate and foster medical and social research in the area of multiple births and to provide assistance to mothers with the special problems that they and their offspring will encounter.

Mr. Keith is a Logistician and Systems Engineering Manager, for Science Applications International Corporation (<u>SAIC</u>), a Washington-based consulting company. Prior to joining them, he spent over twenty four years in the U.S. Amy and retired as a Lieutenant Colonel. A native of Chicago, Illinois, Keith was commissioned in the U.S. Army Signal Corps in

1956 from the University of Wisconsin with a Bachelor's Degree in Business Administration.

Keith earned a Master's Degree in Business Administration from Monmouth University in 1973 and graduated from the U.S. Army Command and Staff College in 1974. He is also a graduate of the Signal Officers Advanced Course and numerous other Army courses.

He attained Fellow status in the Society of Logistics Engineers, the Society of Advanced Medical Systems, and the International Society for Twin Studies. He is designated a Professional Logistics Manager, Advanced, by the Air Force Institute of Technology and the Society of Logistics Engineers. He is dually certified as a Professional Logistician and a Professional Resource Manager by the National Security Agency.

His military decorations include the Meritorious Service Medal, Bronze Star Medal with "V" device for heroism in combat with one Oak Leaf Cluster (OLC), the joint Service Commendation Medal, the Army Commendation Medal with two OLC, the Air Force Commendation Medal, the Vietnamese Cross of Gallantry with Gold Star, the Vietnamese Armed Forces Medal of Honour, 1st Class (Heroism) and the Vietnamese Civic Action Medal, 1st Class.

He has over 200 publications, oral presentations, scientific exhibits, research reports, and copyrighted surveys on logistics, multiple birth, and health issues to his credit.



## **Christine Disselkamp (Germany)**

Dr. Christine Disselkamp is a Psycholinguist from Germany who represented the German ABC-Club at the last four ISTS/ICOMBO Congresses in Denmark, Belgium, Seoul/ South Korea and Florence/Italy. As a Board member of the ABC-Club Christine is responsible for research and international contacts.

Some years ago she did a study about triplets, because she wanted to know what it really means to be a triplet. Her research investigates various areas of the development and contains questions about the social and emotional development, about the speech, the identity

development, the physical likeness and about the advantages and disadvantages of being taught together or separately in school. Two hundred and seventy six families with triplets from Germany, Austria and Switzerland have taken part in her study. Christine chose her topic for her dissertation based on her personal experience as a proud mother of 16-year-old triplet boys.


# **ICOMBO Survey**

During the past year, ICOMBO (the International Council of Multiple Birth Organizations) surveyed Multiple Birth Organizations (MBOs) from all over the world. This was done jointly by NOMOTC and ICOMBO, via Survey Monkey, online. For the next few ICOMBO newsletters, I will be summarizing the results of this survey.

Seventeen MBOs responded to this survey request. Sixteen countries were represented: Argentina, Australia, Canada, Chile, Czech Republic, Denmark, Finland, France, Germany, Ireland, Japan, New Zealand, Norway, South Africa, United Kingdom and the United States of America.

In this first article about the survey, I'll go over the results in general. After that, the following articles will be about the individual organizations.

The majority allowed Professional Members (Doulas, physicians, researchers, etc.) to join their organization. The number of Professional Members ranged from five clubs with 1-25 to one club with 100-500.



Eleven of the MBOs belong to the International Society of Twin Studies (ISTS) – and, therefore, are also members of ICOMBO.

In more than half of the MBOs, annual dues were paid by the individual members. Other MBOs had dues paid by the individual clubs/chapters/groups or by their Professional Members.

The two main benefits of membership were a newsletter/magazine and social events. Other benefits included website access (via a members-only section), group-specific services and non-profit/charitable status (as a result of belonging to the MBO). The vast majority of the MBOs did have non-profit status in their country.


The majority of the MBOs were governed by an Executive Board/Board of Directors. Others were governed by either an Executive/Head Office or by their Officers/Chairmen/National Volunteers. Most met twice a year, while other MBOs governing bodies met either once a year or quarterly. Day-to-day running of the organization is done mainly by e-mail, but many MBOs use video chat/Skype or conference telephone calls to communicate with each other.

Only two-thirds of the MBOs had bylaws/governing documents or an annual budget. About half produced an Annual Report.

Most MBOs had <25 volunteers and no paid staff. Four organizations had >25 volunteers, and two had >100 volunteers. One-third of the MBOs had <10 paid staff and one had 11-25 paid staff.

Thirteen organizations create literature addressing topics pertinent to Multiple Birth Families. Some of these booklets/ information packets are free but many must be purchased from the MBO. Continued......

# **ICOMBO Survey ....continued**



Almost all of the MBOs communicated with their members via their website, and most also used e-mail, social media (Facebook, Twitter, etc) and their own newsletter/magazine. Other forms of communication included postal mail, blogs, e-zine and club/chapter representatives.

Eleven MBOs produce a national newsletter/magazine. Most are done in print but some are done electronically. One-third sell subscriptions of their newsletter/ magazine to non-members.

The majority of MBOs advertise via their website or social media, but some still advertise in newspapers or magazines.


Eleven MBOs host a National convention/workshop/conference yearly. Most have about 50-100 attendees while a few have >200 attendees. Most allow non-members to attend. The main activities at these annual events are General Business meetings, workshops, and social events (parties, banquets). The most common type of workshop was about parenting multiples, but there were also workshops about club/chapter/group activities and finances. Most MBOs advertise their annual meeting via their website, with social media and newsletter/magazine communication a close second.

Half of the MBOs hold a yearly event to promote their organization and to raise awareness about multiple birth children.

Ten organizations conduct research with their members. They also provide their membership with information concerning research studies done by outside sources. Research is mainly conducted using survey tools, like Survey Monkey, but e-mail and Website communication were also done. To a lesser degree, contact was made by postal mail or through their newsletter/ magazine. Seven MBOs worked with researchers outside of their organization.

When asked if there was a twin or multiple birth registry in their country, 1/3 said Yes, 1/3 said No, and 1/3 were not sure.

Thirteen MBOs responded that they were aware of the "Declaration of Rights and Statement of Needs of Twins and Higher Order Multiples" written by ICOMBO.
